Q: What is the Silent Auction and when will it take place?

A: OBL and ILFI are hosting the fifth annual PAC Silent Auction on Friday evening, Sept. 10, in conjunction with the American Bankers Association. The Silent Auction raises funds for the industry's political efforts and has become one of the highlights of the Convention. Those who donate gifts are recognized in pre-convention marketing materials, the Silent Auction catalog and in signage at the event. In addition to the bidding that evening, attendees can bid on certain items throughout the Convention. Bidding will culminate with the Desserts & Cordials Reception.

Q: How do I donate a gift?

A: Complete all fields on the attached donation form indicating that you would like to donate an item. Mail, fax or email the form by Friday, Aug. 13 to the ILFI offices (see reverse for address).

Q: Do I have to purchase my gift individually or can I purchase it on behalf of my bank?

A: Gifts may be purchased with individual or corporate funds and contributed to the OBL or ILFI by any bank or affiliate member. One of the great things about an auction is it gives bankers who do not want to ask their colleagues to get involved politically a different way to support their industry's PAC.

Q: Who may contribute gifts for this auction?

A: Any member bank or thrift, any affiliate member, or any officer or director of a member or affiliate member.

Q: I'm not a good shopper. If I donate a cash gift can the ILFI purchase a gift for the auction?

A: ILFI staff will be happy to purchase a gift. We will make sure you receive appropriate recognition for your donation.

Q: Once I purchase my gift, where do I send it?

A: Gifts can be shipped to ILFI in advance or delivered in person. If you choose to ship your gift to ILFI, please arrange for it to arrive by 5 p.m. on Sept. 3.
